Members unanimously agreed to bring forward item 11 – Strategic County Councillor Updates.

County Cllr Beynon was in attendance to give an update regarding car parking, he advised of the following –

- · Parking in Morpeth Town centre will remain free of charge;
- There will be 30 new spaces provided at Morpeth Railway Station at a charge of £3 per day. Parking permits will be available at £220 per annum, with a view to allow 3 months and 6 month permits to be purchased;
- There are talks with land owners to provide more spaces at the station;
- County Councillor Glen Sanderson and SENRUG are in favour of the charges and understand the reasoning behind it;
- Aside from more parking at the station, with the relocation of Morpeth First School, it's hoped that there will be up to 150 space on the redundant site.

County Cllr Beynon also advised that to alleviate inconsiderate parking as a result of charging at the station, he will be doing a leaflet drop to residents in the area to see what the best solution would be to suit most residents.

One member of the public arrived at 6.35pm.

Cllr D Bawn advised members that following consultation, the Local Transport Priorities (LTP) are now being finalised and Northumberland County Council (NCC) support the recommendations from Morpeth Town Council (MTC).

Cllr R Wearmouth advised members that £7.7 million from central government has been given to the County Council to be used by the end of March for road repairs in the county. This amount should cover all request received for repairs to be carried out.

Cllr Beynon left the meeting at 6.50pm.

The Clerk advised members that the Town Council are governed by the NJC terms and conditions. These are arrived following negotiations with the Joint Trade Union on behalf of the employees and NALC who represent the employer. She also advised that 2017 saw the end of a four year pay freeze and a subsequent pay deal over two years which has seen the lower scale

increased significantly. Due to this, from April 2019 all Council's will be paying its employees a minimum of £9 per hour. Councillors had a lengthy debate on the pros and cons of the motion.

County Councillor Updates - Appendix E

Cllr R Wearmouth

The county council has moved the Local Plan to the next stage which is the regulation 19 Consultation. This will commence in late January including a drop in at Morpeth Town Hall.

On Friday 18th the council launched "Discover our Lands" which aims to build on "Great Northumberland" and the recent award of gold to Northumberland in the National Tourism Awards. The team behind Discover our Lands are seeking short videos and stories showing off what is unique and best about our county, in all aspects of life (e.g. tourist attractions, businesses, peoples positive experience, lifestyle etc). It is aimed at everyone and everyone but in particular about driving up our visitor numbers, making sure the best talent is happy to locate where etc. Ideas from Town councillors are very much welcomed and can be forwarded to ann.bridges@northumberland.gov.uk who is the head of coms at NCC.

The ideas/projects used will include a nice video easily shared through social media email etc, they look very professional so well worth it for Morpeth and any one doing them. The preference is not for politicians but for residents and businesses to step forward and tell the story of our County.

Locally there is a stone planter being removed from Spelvit Lane at the request of residents. There has in the last few months been repairs to Spelvit Lane and some other estate roads. I understand that Highmoor will be resurfaced in the coming months. Regarding the entrance to the Kylins we are apparently waiting for the team to finish work near the Snowy Owl (Cramlington) and then they will move on to the Kylins in the next month or so. On minor repairs (pavings etc) I have forwarded some issues on Leland, Green Acres, Highmoor and the Pastures to Local Services.

The 151 officer is not yet returned to work, this continues to slow progress on discussions about Storey Park. By the time this paper is sent out there will have been the latest Morpeth Forum so I can verbally update on the night on that subject.
